CASA Update

January 20, 2019 -Curtis asks congregation at family meeting whether he should become a *Court Appointed Special Advocate* (CASA). Those at the meeting unanimously said yes. The idea from Curtis was to expand his contacts in the community.

From 5-12-2019 "Timeline" document

Community contact from the CASA initiative:

- 1. 3 district judges and their court staff.
- 2. CASA lawyers as well as lawyers of each child and parent.
- 3. CASA leadership (3) in Brewster and surrounding counties.
- 4. 5 additional CASA volunteers.
- 5. Children protected by the court. I am appointed by the court as "guardian ad litem" of 13 children as of May, 2020.
- 6. I also interact with four elementary schools, two middle-schools and five placements for the children.
- 7. When I wear my CASA shirt while walking I am stopped by people and asked if I am a volunteer, then thanked for my service.
